CMPD Sgt. Don Belz attended tonight's meeting.

Officer Schwartz was asked questions from residents concerning:

- A possible incident on Farmbrook. Officer Schwartz indicated that no report has been filed.
- Gas stolen from a pickup truck on Woodlawn. Again no report has been filed. Officer Schwartz urges everyone to report incidents when they happen.
- Officer Schwartz provided an update on resident's concern about traffic coming out
  of the Montclaire Elementary School at 5801 Farmbrook Drive. She indicated that
  CMPD had addressed this with the school staff. Residents indicated that this issue
  still happens about once a week. Officer Schwartz indicated that they would
  continue to follow-up with the school staff in an effort to get this issue corrected.

Officer Schwartz also discussed the new sidewalks being installed on Murrayhill Road and reminded everyone that you cannot block the sidewalk by parking on it. It is illegal and can result in owners being cited. When residents see sidewalks blocked they can report this to 311. If this is happening repeatedly residents can call 911 or send an email to Officer Schwartz or Lt. Hursley to address.

## Jacobi Jones Liberty Mutual Agent, discussing - Security At Home

Madison Park HOA welcomes Jacobi Jones back as a National Night Out 2012 Sponsor. Mr. Jones referred to the example of a reported burglary where the intruder entered through a second story unlocked open window in the back of the house. Specific things that residents should do are:

- Do not leave windows or doors unlocked.
- Do not leave valuables out where they can be seen.
- Lock garage doors and side garage door entrance. Do not leave garage entrance door to the home unlocked even if the garage door is down.
- Meet and get to know your neighbors and look out for each other.
- Don't broadcast that you will be going out of town.
- When traveling out of town either have a neighbor pick up your mail or stop delivery
  of the mail. You can go online at the USPS website to do this. The same holds true
  for your newspaper as well.

Always document incidents. If not emergencies report the incident to 311.

All of the following statics can be found on the CharMeck website (this link can be found on the Madison Park website). January 2012 compared to January 2011:

- 5 more homicides
- 153 robberies compared to 108 robberies in 2011
- 228 aggravated assaults compared to 168 aggravated assaults in 2011
- 15.4% increase in burglaries

Mr. Jones also reminded everyone that Madison Park residents receive a discount on their Auto and Homeowners insurance through Liberty Mutual Insurance.

A resident asked how they arrived at replacement value of a home. Mr. Jones indicated that land is not included in this replacement cost. Things that are included are how the home was built, type of flooring, year the roof was installed, garages, and square footage among other things are used to determine the replacement cost. He also indicated that if a homeowner has had any upgrades to the home that they should update their homeowner policy.

# **Candidate for Mecklenburg County Commissioner at Large**

Trevor Fuller is running for Mecklenburg County Commissioner at Large and attended our meeting tonight to introduce himself to the Madison Park residents. He is a local attorney who has his own firm, is a family man with 2 school age children. He is running for this seat because he believes that we need strong capable leadership. His focus is on education, job creation through business incentives linking incentives to jobs created here, and efficient and effective use of public funds on social services. He indicated that May 8<sup>th</sup> is the date of the primary election and asked everyone to vote.

# Dogs @ Madison Central Park

President Doss had two different residents complain to him in one week because of dogs off leash at Madison Central Park. One resident had concerns for her child and the other for her dog who was on a leash. The HOA requests that residents be respectful of their neighbors and please have your dogs on leash at the park. This is not a dog park. Also please pick up after your dog. To help reinforce this issue we are looking at purchasing a couple of signs to install. One sign found has both dogs on leash and pick up after your dog on it.

An example of the sign is shown below. Motion was made to purchase two signs at \$19.95 each; a vote was called and was adopted unanimously. Residents expressed concern that CMS also be in agreement with the installation of the signs. The association will contact and obtain their approval.



## Parking On Sidewalk or Across Sidewalk

We are already hearing complaints from residents out walking about certain homes along Murrayhill blocking the sidewalks while parking in their driveways. In some cases residents could have clearly pulled forward and not blocked the walks. Residents blocking the sidewalks partially, parking across them, or parked on them as a driveway are breaking the law. The HOA will attempt to help educate just in case anyone is not aware through our web site and through our HOA meeting via these minutes. Pedestrians that find the walks blocked (especially on a regular basis can call 911 to have it addressed). Calling 911 will not take police away from more important calls. These type calls will be low priority and will be worked in after the current more important calls. Officers are in the neighborhoods now anyway. In past years CMPD has had to address this same type issue along Seneca Place and even Wedgewood when some homeowners chose to use the walks as their personal driveways. A few even ended up with tickets after they even ignored visits from the police.

If you do not have enough parking currently you have a couple of choices.

- 1. Enlarge your driveways or parking pads per the city ordinance.
- 2. Park on the street (all 4 wheels).

CDOT had told the HOA that they worked with individual homeowners that worked with them to maximize their parking in their driveways.

Also remember when you are parking on the street that all 4 wheels need to be on the street. Parking partially on the street and in the yard or planting strip is considering parking on the lawn. This is addressed by 311 and code enforcement and also can result in fines or even being towed.

## **CDOT Digital Feedback Signs**

Last month CDOT installed the requested 25 MPH additional signs near the digital feedback signs on Tyvola. CDOT also at some point reprogrammed the signs to show driver speeds above 40 MPH. The signs used to only strobe when I driver hit 40 or above. There are still some speeding issues with some cars. CMPD has been notified of the issue.

## 311 Online Code Reporting Issues

President Doss noticed 311 on-line reporting for code related issues were not working on 3/1/12. The links were all taking visitors to dead links. 311 were unaware as they use a different screen to enter calls to 311 from citizens. There is an on-line link to report dead

links. After 24 hours President Doss alerted the City Manager to the issue. He received e-mail from the Director of 311 Janice Quintana. He called Janice and walked her through what was happening. They were unaware the system was down. Janice responded she would work with the IT department, and alerted Beliverie Ross, the program manager for Charmeck Web site to the issue. The site was corrected later that day and was confirmed back to Marty Doss via e-mail on 3/2/12.

# **CDOT Ken Tippette Bike Route Missing Sign**

Ken, with bike routes in CDOT, was unaware the directional bike route sign heading West Bound on Seneca Place between Lamont and Wedgewood was missing. This was one of the signs that were reported to 311 and CDOT that came down last fall when the telephone pole was broken and replaced on Seneca Place. CDOT did eventually get the other signs up. President Doss alerted Ken on 3/2/12 that this one sign for the bike route was never replaced. Hopefully, Ken will be able to have the sign replaced. Someone trying to follow a marked bike route could miss the turn on Wedgewood without this sign being up.

# Rose Garden Work Day 3/4/12

Seven people showed up to prune the rose bushes on Sunday 3/4 including Councilman Andy Dulin. It took about 2 hours to complete the work. Hopefully, the spring will bring lots of roses. Andy also purchased an American Flag for the flagpole at the park. Andy also indicated he would purchase a solar spotlight so the flag would be illuminated at night.
