Traffic Calming (speeding) on Halstead:

Officer Mohammad reported that CMPD continues to monitor Halstead to help with traffic calming on the street. Both warnings and citations have been given to persons speeding in the area.

The following information has been presented by CMPD at previous meetings and we will continue to post this to the Minutes throughout 2014:

- CMPD suggested be sure to keep blinds, shades and curtains closed at night as well as to secure your ourdoor sheds and electrical boxes to help avoid crime.
- Residents should **keep an inventory** of their electronics, jewelry and other personal items (including serial numbers where applicable). Pictures and serial numbers help the police find stolen items faster especially when they are pawned so be sure to take an inventory and keep it in a safe location.
- Residents are to be aware that there are people who come into the neighborhood and stand in front of homes to connect to residents Wi-Fi internet. Be sure to **Password protect your Wi-Fi connection** and report anyone suspicious in the area by calling 911.

Safety Starts At Home What You Can Do To Keep Madison Park Safe

- 1. Make sure your house is well lit. Turn on outside lights, spotlights, motion lights, etc. Leave several inside lights on timers while you are away to give your home that lived in look.
- 2. All exterior doors should be steel or made with a solid core. Deadbolts should be used to lock and secure your doors. A good deadbolt should have a 1" throw. If you have glass within 40" of the lock a burglar could reach in and unlock the door. A double cylinder lock (this type needs a key on both sides to unlock) should be used if glass is near the lock.
- 3. With sliding glass doors a pin through the frame, a locking device or broomstick in the track will help prevent the door from being opened from outside.
- 4. Do not leave a spare key hidden outside your house. Do not leave extra keys to your home or vehicle inside any of your vehicles, even if they are parked inside your garage.
- 5. Landscaping should not create hiding spaces or block windows or doors of your residence. Trees and shrubbery should be properly pruned to keep them from providing access to upper floors and creating blind spots.
- 6. Secure windows with locks or pins for both closed and partially opened positions. Use blinds and curtains for privacy.
- 7. Remove anything an intruder could use to gain access to your home i.e., ladders, wood, tables, chairs, lawn tools and children toys.
- 8. As an added since of security some residents have installed alarm systems. Consult with alarm companies for differences in the systems and decide which would benefit you. The alarm system can only help if it used. The Charlotte-Mecklenburg Police Department requires that alarm systems be registered with the police department.

Guest Speakers

<u>Brian Sturgill & Sophia Hollingsworth - CharMeck Connected Government -</u>. Connected government (also known as e-gov, digital government, or online government) refers to the use of information technology to transform government operations, engage citizens, and provide government services. It is an enterprise's predominant customer service strategy and drives technology priorities and resources. In general, it is a way of connecting local government with the public in an electronic format that the public can easily access.

They opened their session, by asking some questions about how well residents knew about their local government. Did you know city elections are held on odd numbered years and county elections are held on even numbered years? Thus this year's elections are all county elections, county council NOT city council. Did you know if you need a speaker for an event, you can go to meckconnect.org to find one?

Initiatives currently in place:

- CharMeck.org redesign of the County website to represent modern browser experience including addition of responsive design and accessibility features.
- Enterprise Architecture establish a common terminology across agencies and consumers to define structures, people, places, and things. Provide better ways for business partners to interact with and integrate with existing County data sources.
- Open Data currently engaged with the City of Charlotte and Code For America to deliver a What's Happening application that will allow citizens to subscribe to a variety of events happening within a geographic location (demo of ongoing product: http://vimeo.com/99661866)
- Business Intelligence provide dashboards and other data representations to Citizens to access current and relevant information (Budget Dashboards: http://charmeck.org/mecklenburg/county/County/ManagersOffice/OMB/dashboards/Pages/default.aspx)

<u>Jodi Anderson & Reed Hunt – Charlotte District Attorney's Office</u>. They discussed how the District Attorney's personnel are assigned to various teams and may work on different types of crimes. The teams are: Misdemeanor, Misdemeanor Appeals & Probation Violation, Domestic Violence, Drug, Crimes Against

Property, Crimes against Persons, Homicide, Sex Offense, Juvenile and Habitual Felons. More information regarding the local office structure may be found on: http://charmeckda.com/districtattorney/officestructure.html

They briefly discussed the structured sentencing laws in North Carolina devised by the NC General Assembly. Structured Sentencing is the method of sentencing and punishing criminals based on the severity of the crime along with the extent and gravity of prior criminal record. Based on these two factors, it provides judges with sentencing options for the type and length of sentences which may be imposed upon a guilty verdict. Class A felonies results in automatic prison sentence while a Class I felony results in Probation. They also briefly discussed the Three Prior Felonies are considered three separate occurrence – convictions without crossovers. They explained the difference between B & E (no one at home) and Burglary (B&E when someone is home). They also discussed legal process from a DA's perspective and provided updates to current open items. Individuals who have been vicitims of crime may contact the DA's office at 704-686-0700 to obtain a status on the case. Note, the DA's office does not post or publish case information nor do they provide information to citizens who do not have an open or pending case. "Park at Montford" mixed use proposed development

Park on Montford rezoning petition has been withdrawn by developer, Selwyn Property Group. Based on feedback from the community in regards to the proposed development, Selwyn Property Group has withdrawn their rezoning petition for the properties between Park Road, Woodlawn and Drexmore. It has not yet been determined if the developer will pursue purchase of the property as the proposed development was contingent upon rezoning. The area is currently zoned for commercial use and the developer was petitioning to rezone to allow for residential (apartments) and commercial use.

<u>Tree banding Grant</u> – The HOA will apply for a neighborhood grant to obtain funds to allow the community to receive discounted rates to band their trees in the Fall for canker worms. We have partnered again with SilverDuck Tree banding to meet with the city and apply for a grant.

There will be a pre-application meeting in August that Valerie Delby will attend on behalf of the community, and then we will officially begin the application process which is due Sept. 1.

It should be noted that Tree banding is the only grant eligible to apply for when a community is in process of another primary grant. Madison Park will apply for grant funding for Pinewood Elementary's after school program and marketing efforts in Sept, which is the same time period that we will also apply for Tree banding.

We will continue to update the community as we move through the process.

Traffic Calming Speed Hump - NEW CDOT INFORMATION

There was an open discussion regarding the desire for an additional speed hump off Wedgewood. The HOA contacted CDOT in regards to rules for speed humps and Chip Gallop of CDOT informed us that **CDOT no longer funds speed humps (regardless of traffic count)** as they deem this as the responsibility of the neighborhood. This is a change to the former regulations that allowed CDOT to fund the speed hump if a threshold of 1,000 vehicles per day used a road (or section thereof). That is no longer the process.

As part of the current rules, CDOT is available to install speed humps as a fee of \$2,400 each.
